In Support of Revising Dissertation Policies

Summary: A resolution urging the Graduate School to change language in the Graduate Catalog and recommending codification of dissertation requirements.

- **Whereas(1):** The Graduate School requires the submission of a dissertation prior to graduating with a doctoral degree¹;
- **Whereas(2):** A dissertation in the Graduate Catalog is defined as "An original contribution to scholarship, the result of an independent investigation in the major area, and must be approved by the dissertation committee²;"
- **Whereas(3):** Current practice at the departmental level deviates from the language in the catalog³;
- **Whereas(4):** Departments across campus define the requirements as a document, as a set of combined published articles, or other scholarly works produced by the student⁴;
- **Whereas(5):** Different academic disciplines place varying emphasis on the importance of publication of documents;
- **Whereas(6)**: All departments that award doctoral degrees require a dissertation committee that review and approve individual dissertations⁵;
- **Whereas(7)**: Not all departments have explicitly stated the requirements and format of a dissertation;

- **Whereas(8)**: Peer institutions including University of Minnesota, University of North Carolina Chapel Hill, and University of California Los Angeles provide flexibility in dissertation requirements whether they come in the form of a document or as a set of combined published articles⁶;
- **Whereas (9):** That the graduate students of the University of Texas at Austin urge that dissertation requirements should continue to be under the purview of individual degree granting programs.

Resolved (1): A dissertation in the Graduate Catalog be redefined as "An original contribution to scholarship *as codified by each department* and must be approved by the dissertation committee."

Resolved (2): That every degree granting program codify the requirements of dissertations for their specific program.

Resolved (3): That these requirements be included the Graduate Catalog.
